

# **AARP Chapter 2426**

## **Minutes from the June 21st, 2017 Meeting**

President **Petr Skalnik** called the meeting to order at 1:00pm

Vice-President **Elaine Benton** led the Pledge of Allegiance.

### **Special Request**

**Dr. Tracie Harrison**, professor of Adult Health Nursing @ UT Austin, School of Nursing, announced that they will be conducting a follow-up study concerning Arthritis and Aging With a Disability in the female Hispanic population. Areas to be studied are whether elderly Hispanic women manage disabilities different from the non-hispanic population; the examination blood screens to determine whether there exist any differences in the actions of disability causing agents and what roles do age, gender as well as family cohesion play in the management of the disability. There will be a \$50 stipend paid to participants and the interviews will be held at the patient's home. **Dr. Harrison** is also the director of the Center for Excellence in Long Term Care funded by the Texas Health & Human Services Commission.

**Old Business:** Pete explained what happened at the last meeting where one of the speakers had to be asked to halt her presentation. The reason was that the subject being discussed (Crypto currency/Bitcoins) had switched from being informative to one of a commercial offering in nature, which is not allowed by AARP by-laws.

**Tim Morstead and Blake Hutson** of the advocacy staff from Texas AARP provided a legislative update at our June meeting. Although there are many issues still to be fought for, they noted success stories in the passage of bills such as: Major reforms to improve the quality of care in nursing homes; New rights for unpaid family caregivers; Bills to fight elder financial exploitation; Legislation clarifying powers of attorney and guardianships; Measures bolstering consumers' power to prevent and challenge surprise medical bills; and Telehealth legislation to allow patients to meet with physicians electronically.
