### Old Business

**Pete** is still struggling with the classification of the Chapter 2426 as non-profit for tax purposes. This issue has lingered far too long and need resolution. It may require more input from the National AARP.

**Pete** announced that **Jessica Lemann**, Associate Director for Advocacy and Outreach, AARP Texas, sent him an email showing that as things now stand, the new Federal budget proposal is not encouraging. For those not on Medicare, the current Affordable Health Care Act (aka Trumpcare) guidelines look like as many as 10 million people stand to lose coverage either by not qualifying or by not being able to afford new premiums. The State AARP office is seeking volunteers to go on camera to show how they will be negatively affected if these proposals are implemented. **Diane McGowan** will send out an email asking for volunteers and a notice will also be posted on the SASAC bulletin board
